Fifty years ago today, the Rev. Martin Luther King Jr. was assassinated at the Lorraine Motel in Memphis, Tennessee. This somber anniversary is being <u>commemorated in many ways</u>, including with <u>reflections</u> on current progress on poverty, race, peace and other issues for which Dr. King fought. (You can see the New York Times front page from April 5, 1968 <u>here</u>, and King's obituary <u>here</u>.)

Columnist Michael Sean Winters, for whom King's funeral was his first memory of a public event, calls him "<u>a great American and a genuine Christian prophet</u>" and recalls that Pope Francis mentioned King during his visit to America. (A Vatican official said <u>King's dream lives on in the pope</u>, who is an admirer of the late activist). Patricia Lefevere sees <u>King and Thomas Merton as spiritual brothers</u> who knew they were living in a *kairos* moment at a providential time.

Of course, King was in Memphis to support striking sanitation workers. These days it's public <u>schoolteachers who are taking to the streets</u> — in South Carolina, Oklahoma, Kentucky and, next, Arizona — to demand fair wages and benefits. And non-tenure-track and part-time faculty at Loyola University, who recently unionized, <u>are striking today over issues of pay and benefits</u>. In other labor justice news, employees of the Diocese of LaCrosse in Wisconsin many of whom worked for low salaries and counted on their pensions to get them through retirement — will <u>instead receive a lump sum payment that will be less than</u> <u>their full pension</u>.

Canon lawyers interviewed by NCR's Vatican correspondent Joshua McElwee believe the punishment for the Guam archbishop found guilty last month by a Vatican tribunal indicates that it was <u>not likely for the allegations of sexual abuse made</u> <u>against the prelate</u>.
