



First, the news out of Washington. Jesuit Fr. Patrick Conroy, will continue as House Chaplain, after he rescinded his resignation and House Speaker Paul Ryan changed his mind about the priest's ouster. We have some <u>Catholic House members' reaction</u> in our story.

<u>EPA Administrator Scott Pruitt, already under scrutiny for questionable spending and ethical decisions, paid himself nearly \$65,000 in reimbursements</u> from his two campaigns for Oklahoma attorney general, making it impossible to confirm whether the expenses were legit or not.

Catholic colleges and universities are arguing they should be exempt from laws they claim conflict with their Catholic missions, but it's difficult to understand how anti-discrimination statutes or the right to unionize conflict with a Catholic mission. One example, Chestnut Hill College in Pennsylvania, which is now awaiting mediation about a racial discrimination case after losing in state court.

Arizona parents are breathing sighs of relief as their children head back to school today. The governor has agreed to a <u>substantial raise for teachers and more funds</u> <u>for their classrooms</u>. It's the fourth state to successfully to win education concessions from conservative lawmakers.

After meeting with four German bishops, the Vatican has asked them to <u>adapt a proposal to allow non-Catholic spouses to receive communion</u> so it might satisfy objections from a minority of the country's prelates.

Inspired by their Catholic faith, <u>volunteers from a new ministry accompany detainees</u> <u>to immigration court</u>—they're literally living out Pope Francis' call for a theology of accompaniment.
